April -- Rachel Carson's 'Silent Spring', 378 pp. in 1962. Jim McDermott is presenting.

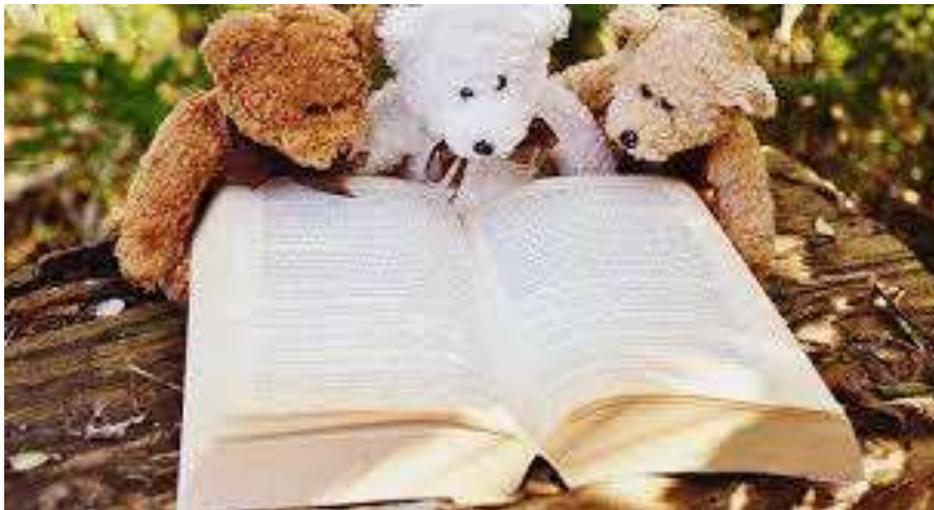
June -- Steadman and Clark's 'Tethered Mercury', 288 pp. Sherry McNamara is presenting.

News from the RVC3

As this article is written for the July issue of your local group newsletter, my first thought is how I am missing being at the Annual Gathering in Kansas City. That has now been moved to 2024. Next year's gathering is a World Gathering. It has been fifteen years since the last one, which was held at Disney in Florida. That was my first national Mensa event. Next year, I hope to see many of you in Houston, August 24 to 29. Yes, it is later next year so that it is easier for our European members to attend during their annual "holiday" period. Local group events continue to be primarily via Zoom and other web-oriented platforms. Some groups are now holding their monthly gatherings with speakers in a virtual fashion. This seems to increase attendance as it allows homebound members to join in. Groups like Chicago Area Mensa are publishing agendas which include social time, speaker time, and games room. Once larger in-person social events are allowed by Governors, I encourage the continued use of the internet in order to include more members than "in-person" alone would allow. Some places are using both Zoom and Facebook Live to reach more folks. Speaking of Governors of our states, please follow their guidelines and executive orders. They do vary considerably. Here in Michigan, we can meet in groups of ten or fewer, must "socially distance", and must wear masks when inside a public building (e.g. stores). In most of the state, restaurants and bars are still limited to curbside, take-out, and delivery. Hair salons are still not allowed to be open even though some of us could use a haircut. My wife has lately been suggesting that we go to Ohio to get a much-needed massage. The states that surround Michigan seem to have moved forward more quickly than Michigan. In fact, Indiana has a billboard near the Michigan border that welcomes Michiganders to a "free-to-roam" state. Indiana has published a five-phase plan with dates and criteria. It is very specific but does include a disclaimer that says that it could change. The Governor of Indiana must know what SMART goals are as the plan follows that approach - which provides hope to its citizens.

The next Regional Gathering (RG) in Region 3 is planned for Labor Day weekend, hosted by Western Pennsylvania Mensa (WPAM). However, that is in question and may be canceled. The Columbus Area Mensa RG in early October has been canceled. The Cincinnati Area Mensa RG is still on for December 4 - 6 but there will likely be changes for the safety of members and volunteers. American Mensa has published a list of recommendations for meetings which includes local group meetings and gatherings, youth events, and testing. In this time of conflicting requirements, even among the states in our region, please be kind and respectful of one another.
